## Spring Meeting, etc.

### From the Chair

Dear Colleagues,

## Directions to Loretto Archives from Lexington (East)

Take the **Blue Grass Parkway West to Exit #42 – Rte. 555**. At the end of the exit ramp, **turn left (South)** towards Springfield.\*

In about 15 miles you will come to an intersection where you pick up **US 150/Rte. 152**. **Turn right at this light onto US 150**. Proceed about 1 mile further, and Rte. 152 will turn left off of Rte 150. There is a Southern States building on the right of the intersection. Rte.152 is also named **“Loretto Road.” Turn left onto Rte. 152**.

Stay on 152 for almost 10 miles. At that point, on the right, a little off the road, you'll see a stone sign that says, **“Loretto Motherhouse,”** and two stone pillars on either side of the drive. **Turn right into the Motherhouse drive**. (If you miss the Motherhouse drive and come to a stop sign and intersection with Rte. #49, you have gone ½ mile too far.)

Go up the Motherhouse driveway and turn right at the top of the hill, just beyond the pine. The Academy/Noviate Building, where some the retreatants stay, will be the first building on your left, and Knobs Haven will be the house on your right. Park your car in the lot directly in front of you.

The Motherhouse reception area is on the first floor of the Infirmary; there is a sign marked **“Office”** which directs you from the parking lot into that building, and up the stairs to the first floor.

**\*Google Maps (and Mapquest) will have you come all the way to Bardstown (Exit 25 on Bluegrass Pkwy) and get on US-150 towards Springfield. This route is about 25 miles longer than the directions described above and shown below.**

## Directions to Loretto Archives from Louisville/Elizabethtown (North/West)

If coming from Louisville (North) take **I-65 South** to **Exit #112 – KY Hwy 245** toward Bardstown/Bernheim Forest. Continue through Bardstown to stop sign where **KY 245 ends at US-150**. **Turn left onto US-150 towards Springfield**. If coming out of Louisville on US-150 (Bardstown Road) stay on US-150 through Bardstown toward Springfield.

If coming from Elizabethtown (West or South), take the **Blue Grass Parkway East to Exit #25 – US-150**. At the end of the exit ramp, **turn left (South)** towards Springfield.

In about 13 miles you will come to an intersection where you pick up **US 150/Rte. 152**. **Turn right at this light onto US 150**. Proceed about 1 mile further, and Rte. 152 will turn left off of Rte 150. There is a Southern States building on the right of the intersection. Rte.152 is also named **“Loretto Road.” Turn left onto Rte. 152**.

Stay on 152 for almost 10 miles. At that point, on the right, a little off the road, you'll see a stone sign that says, **“Loretto Motherhouse,”** and two stone pillars on either side of the drive. **Turn right into the Motherhouse drive**. For the last year or so, the KCA board, along with numerous other national, regional, and state groups, have endorsed the Preserving the American Historical Record (PAHR), a bill designed to provide funding to every state for "projects that preserve historical records and make them more accessible." The bill is being reintroduced and if it becomes law Kentucky would receive more than \$700,000. To be successful, the bill needs balance from both sides of the aisle as well as many areas of the country. You can help by contacting your Representative and urging him to co-sponsor and/or support this bill. ### UK Develops Online Research Tool

The University of Kentucky Archives announces the creation of Explore UK (<http://exploreuk.uky.edu>), a new online resource that aims to preserve the memory of the institution and make university history more readily available. University Archives staff collaborated with Digital Programs Department staff in developing the research tool, and expanding the availability of historic items frequently requested by researchers, alumni, current students and faculty.

Explore UK brings together text-based and other visual materials that can be browsed or keyword searched. Many more resources will be added. Currently, the site offers searchable photographic images; Board of Trustees minutes (1862- 2007); and University of Kentucky Yearbooks (1894-1975). In the next


year, an expanded Athletic Archive will be made available for researchers and fans.

# The Kentucky Archives Month Report

Planning for Kentucky's annual celebration of Archives Month is well underway. The Archives Month Coordinating Committee, under the direction of the Kentucky State Historical Records Advisory Board, met in March to begin preparations for this year's celebration which will be held in October 2009. Our theme for this year is Abraham Lincoln in honor of his 200<sup>th</sup> birthday.

The committee is excited to announce two competitions for this year's celebration: the Kentucky Archives Month Poster Contest as well as the Kentucky Archives Month Video Contest. We are working with the Kentucky Junior Historical Society and the Kentucky National History Day Celebration to announce these contests.

The poster contest will be open to all Kentucky students, kindergarten through eighth grade and the winning poster will be printed as part of this year's Kentucky Archives Month Poster. The poster must represent Abraham Lincoln. This poster will also be submitted to the American Archives Month poster contest, *Picture This!*, held in conjunction with the Society of America Archivists Annual Meeting in August 2009. The video contest will be open to all Kentucky high school students, grades 9-12 and the winning video will be made available for viewing on the Kentucky Archives Month website. The video must show documentation concerning the research process and the use of primary source material. A process paper and bibliography must also be submitted with the video. The coordinating committee would like to take this opportunity to thank KCA for its continued support of Kentucky Archives Month and hope that this year's celebration will be our best yet! We encourage all Kentucky archival and manuscript repositories to commemorate Archives Month in some way, with an open house, a workshop, a featured speaker, an exhibit, a tour, or any other type of event.

## YOU CAN HELP PRESERVING THE AMERICAN HISTORICAL RECORD

A Message from State Archivist Barbara Teague

I'm contacting you to ask for your help in securing passage of the "Preserving the American Historical Record" (PAHR) bill, which will be introduced in Congress in 2009. The bill was first introduced last year and the PAHR Task Force was very encouraged by the response. If funded at the target amount of \$50 million, Kentucky's share would be over \$700,000 per year, which would be distributed by the State Historical Records Advisory Board to archival and records management programs throughout the state.

We have a good chance to get the PAHR bill passed this year. Congressman Maurice Hinchey (D, NY) and Congressman John McHugh (R, NY), recently sent a request to the members of the House of Representatives inviting them to sign on as co-sponsors for the bill. **Please consider contacting your representative in Congress to ask him to be a co-sponsor of the PAHR bill.**

When I was in Washington several weeks ago for a meeting of the Council of State Archivists Board of Directors, I was able to speak with staff in the offices of Congressmen Chandler, Yarmuth, and Rogers. I found the staff very encouraging and interested, and welcoming of constituent comments. If you live in one of those districts and would like further information about contacting the staff members with whom I spoke, please let me know.

**In the last session of Congress, we did not have any co-sponsors of the PAHR bill from Kentucky, so let's work together this time to change that!** Please use the links below to contact your representative. Calls, faxes, and emails are all effective, but the postal mail is still delayed because of security.
